As Board Chairman for 2020, I worked with the staff of GROW Licking County to focus on an expanded platform to promote foreign direct investment (FDI), expanding Licking County Works to serve as a resource for our local employers, and hiring new staff to build out the full team. The year started with tremendous momentum.

And then March happened.

As the organization began to understand the depths of the pandemic and how it would shift our operations, GROW refocused efforts. The FDI plans had to be scrapped, staff employed a robust Business Retention & Expansion (BRE) effort and Licking County Works diversified as a platform for resource sharing connectivity during the crisis.

As time moved on, momentum built back up. We saw the best of the Licking County economy with many of our employers contributing daily to help the lives of residents. Essential workers continued to move our economy forward. Organizationally, the staff never lost momentum.

As the lights came back on, many of our local employers were looking to evolve their businesses to meet current and future growth needs. As we finished out 2020, nine project commitments totaling nearly \$500M in capital investment over five of our communities were announced. What's more telling is the pipeline continues to be robust, spanning the manufacturing, logistics, data, and energy sectors. 2021 looks to be an exceptionally successful year for GROW!

As I first served as Chairman of GROW Licking County CIC in 2016, there was a phrase which I frequently think about: You are either getting better, or you are getting worse – nothing ever stays the same.

Licking County was coming off a year of unquestionable trials and triumphs: How do we continue to grow our local economy while balancing the global interests of our public and private partners? It won't be easy.

Over the coming year, I plan to lead the organization as we double down on BRE conversations as well as develop new tools to engage the commercial real estate and site selector community to promote new growth opportunities in Licking County.

Our goal? To continue to build momentum and ensure that Licking County remains the premier destination for new economic-growth opportunities in Central Ohio.

SITE DEVELOPMENT

GROW led the charge in speculative development and site preparation through engagements with local officials and developers as well as advising municipalities on strengths and weaknesses. This work will ensure readiness for future projects. There are currently over 4 million square feet of speculative development under construction or announced. Developer-driven speculative development has the potential to top 10 million square feet in the coming years.

ANALYSIS CONDUCTED OF SKILLS GAP

Miller and Associates (TPMA) to conduct a Workforce Needs Assessment aligning local curriculum and skills development activities to employment opportunities.







