# LICKING COUNTY ECONOMY

A recent national report shows that Licking County's economy is in the narrow 7% of 3069 counties across the nation to show a full recovery from the most recent recession ending just over 6 years ago. In Ohio, Licking County is one of only 9 counties to show a full recovery. These findings are based on 4 key indicators: jobs, unemployment rate, economic output (GDP) and median home prices. # 2015 KEY PROJECTS

In 2015 more new and existing businesses discovered that it's easy to do business in Licking County because of our strong infrastructure, diverse workforce, highly accessible transportation, exciting financial incentives, and the pro-business attitude shared by government officials and residents alike. We're proud to share a few key projects that have come to fruition in Licking County.





#### **VELVET ICE CREAM**

In 2014, family-owned Velvet Ice Cream celebrated 100 years of high-quality ice cream making in Utica at the historic Ye Olde Mill. This past year, they announced their largest capital project to date: a new 21,000 square foot warehouse and distribution space at their headquarters. This \$3 million dollar investment, will allow Velvet to produce more product to keep up with growing demand and facilitate further growth into new markets.





#### **AMAZON FULFILLMENT CENTER**

Perhaps the most high-profile of Licking County project announcements for the year, online retailer Amazon finalized plans to construct an 855,000 sq. ft. fulfillment center in Etna Township. The building is being constructed at the Prologis Park70, located directly off of Interstate 70. This distribution center is one of two in the state that comprise Amazon's first sites of this kind in Ohio. Jobs created by this expansion will total up to 1,500 new positions and is likely to spur further growth in the region. Construction of the new facility is well underway and could be finished as early as September of 2016.

Amazon's new and growing presence in Ohio is good news for the entire state and central Ohio region. Most importantly, it is no small feat that Licking County has proved, not once but twice, to have the resources necessary to support two of the four developments in the state.



#### VADATA (AMAZON WEB SERVICES)

Vadata, announced in mid-2015 that it would be locating one of three data centers in New Albany, north of the Personal Care and Beauty Park. The \$300-million facility will occupy 150,000 square feet and create a minimum of 25 skilled jobs.





#### **APEKS SUPERCRITICAL**

Apeks Supercritical moved in to a brand-new facility, marking the completion of phase one of a two-phase expansion announced in 2014. The company was named the 2nd fastest growing business in central Ohio by Columbus Business First as part of the annual Fast 50 ranking in 2015.



#### **MPW INDUSTRIAL SERVICES**

In 1972, the concept that was soon to be known as MPW Industrial Services bought its first cleaning truck. Now, they are a nationally recognized provider of high-quality, low-impact, safety-first, industrial cleaning and water purification services. They have continued to expand over the past 44 years, and in 2015 announced a \$10 million expansion to add a 76,000 square foot engineering and technology center to the headquarters in Hebron. The project will create nearly 60 jobs over the next five years, and serve as a foundation for future growth in Ohio and across the United States and Canada.





#### **ARIEL CORPORATION**

Ariel Corporation, headquartered in Mt. Vernon, Ohio, expanded into Licking County last year, setting up shop in a newly constructed speculative building from Southgate Corporation. The new 50,000 square foot facility at the Central Ohio Aerospace & Technology Campus increased Ariel's manufacturing capacity for the production of reciprocating compressors and created 100-150 new skilled jobs. Ariel is the largest manufacturer of separable reciprocating gas compressors worldwide.

## PLANS FOR 2016 (AND BEYOND)

As part of a strategy for raising awareness of Licking County (and the sites and communities that call Licking County home), GROW will be undertaking a multi-media/ multi-prong approach to better position ourselves in the Central Ohio/Midwest marketplace.

#### **THESE EFFORTS INCLUDE:**

- Radio advertisements on local and regional radio outlets discussing opportunities and economic development efforts here in Licking County
- Traveling to various domestic and foreign trade industry shows with the intent to recruit industry and investment to Licking County
- Pursuing digital media opportunities in regional business publications discussing opportunities for development in Licking County
- Raising the awareness of Licking County through the sponsorship of events with Central Ohio's Chapter of NAIOP (Commercial Real Estate Development Association)
- Strengthening regional relationships with economic development-based associations
- Sponsoring various economic development trainings and discussions over the course of the next 12 months
